

## OACDL Sex (Crimes) Seminar BIOGRAPHIES

### Robert Hirschhorn

Mr. Hirschhorn is a nationally recognized expert in jury and trial consultation. He is co-author of Blue's Guide to Jury Selection. In 2005, he selected juries that returned more than \$750 million in verdicts – cases including Lexar v. Toshiba (breach of fiduciary duty; \$461 million), and Ernst v. Merck (1st Vioxx litigation; 253 million). He has also assisted lawyers in high profile cases including State of Florida v. William Kennedy Smith (sexual assault charges, not guilty verdict), State of Texas v. U.S. Senator Kay Bailey Hutchison (ethics charges, not guilty verdict) and State of Texas v. Robert Durst (acquitted of murder charges). Mr. Hirschhorn has appeared on Good Morning America, MSNBC, Court TV, CNN, Dateline NBC, and many others. He lectures nationwide to lawyers and judges on the art of jury selection.

### Brian McMonagle

Brian McMonagle began his career in the Philadelphia District Attorney's Office. He has successfully handled some of the most celebrated cases in Philadelphia's history, including a stunning victory for Philadelphia's Deputy Mayor in one of the largest federal corruption cases in the country. Recently, he successfully defended a former Deputy Attorney General facing homicide charges, and a NBA Rookie of the Year who was facing murder charges. His successful handling of high profile cases such as an NBA coach facing felony charges, and a Philadelphia Police homicide captain charged with fraud, has earned him a reputation as being one of Philadelphia's finest trial attorneys. Mr. McMonagle's clients have included movie and television personalities, professional athletes, high ranking law enforcement officials, politicians, CEOs, physicians, clergy and attorneys. Mr. McMonagle was named by Best Lawyers as the Best Philadelphia Criminal Lawyer of 2015, and was selected to the Philadelphia Magazine Super Lawyers Top 100 list in Pennsylvania.
