### OACDL Superstar Seminar

#### Jolie S. Brams, Ph.D.

Brams and Associates, Inc. - Columbus, Ohio



Jolie Brams earned her undergraduate degree from the University of Texas at Austin, graduating with Special Honors in Psychology and being admitted to the Phi Beta Kappa honor society. She has a dual degree in clinical psychology and child development from Michigan State University, where she was a National Institute of Mental

Health Graduate Student Fellow. She completed two years of internship at Upstate Medical Center in Syracuse NY, and Hurlev Medical Center in Flint, MI, where she began a center for the assessment and treatment of child neglect, which still operates today. Beginning as providing forensic services in juvenile matters, she was the pivotal witness in a capital case involving an eighteen year old who executed three people, including his best friend. Her testimony assisted in a sentence of life and not death, and since that time 25 years ago has consulted and testified in hundreds of criminal and civil cases. She applies her knowledge of life span psychology, diagnosis of children and adults, and a multitude of experiences with a broad range of clients and cases to finding answers to complex forensic psychological issues. Jolie has more than 30 years of experience as a licensed psychologist. She is a nationally recognized forensic expert, gualified to testify in multiple state, Federal, and military courts. She is an Adjunct Faculty at The Ohio State University and frequent presenter at legal trainings and conferences. Dr. Brams has authored and contributed to numerous research papers and books. She is also a member Ohio Supreme Court Advisory Board regarding Juvenile Competency Law.

#### C. Mathew Curtin

Interhack - Columbus, Ohio



C. Matthew Curtin is a computer scientist and cybersecurity expert. He leads Interhack's professional practice, addressing matters such as data breaches, intellectual property protection, computer crime, and use of data in litigation. Curtin has been engaged in criminal, civil, administrative, and military processes for both those bring-

ing and defending actions, as well as for the court directly. His opinion has been accepted by federal and state courts throughout the country in hearings, trials, and in appeals. In 1997 he helped to lead the DESCHALL project to defeat the U.S. Government Data Encryption Standard (DES) for the first time in open research using exhaustive key search. His book Brute Force: Cracking the Data Encryption Standard (Copernicus Books, 2005) tells the inside story of the effort and how it led to a change in policy regarding strong cryptography. Curtin was the primary investigator in Interhack's Internet Privacy Project, showing how decisions made in the design and implementation of Internet-connected sys- tems impact the security of computer systems and the privacy of their users. The work has been reported throughout the worldwide media and computer science literature. Curtin's previous book, Developing Trust: Online Privacy and Security (Apress, 2001) discusses these matters in detail. Curtin has held an academic post as Senior Lecturer at The Ohio State University's Department of Computer Science and Engineering, and has guest lectured for the Privacy Foundation at the University of Denver's Sturm College of Law, Otterbein College, Franklin University, the Keller Graduate School of Management at DeVry University, and the Fisher College of Business at The Ohio State University. As a volunteer, Curtin provides public service in emergency communications and emergency response. He is an amateur radio operator (KD8TTE), and carries gualifications and certifications in the FEMA Incident Command System (ICS), National Incident Management System (NIMS), National Weather Service SKYWARN, and is a member of the Franklin County Ohio Community Emergency Response Team (CERT) as well as the Ohio Amateur Radio Emergency Service Mutual Assistance Team (ARESMAT).

#### **Marjorie P. Russell**
