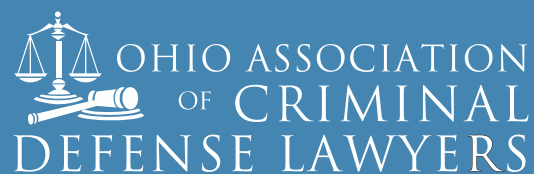

## OACDL DUI Seminar BIOGRAPHIES

### Mark Gardner

Mark Gardner graduated from the Case Western Reserve University School of Law in December, 1992. Since graduation, he has distinguished himself as a public defender and in private practice. During that time he has successfully conducted numerous DUI motion hearing and jury trials. In September, 1997, Mark received NHTSA's instructor certification status in SFST. He has testified as an expert witness on the proper administration and grading of SFSTs in DUI trials in both Pennsylvania and Ohio. He has become a fixture as a lecturer at the annual OACDL's Advanced DUI Seminar, as well as a speaker at DUI seminars in Texas, Georgia, South Carolina, and Arkansas.

### Ken Bossin

Kenneth Bossin received his J.D. from Cleveland-Marshall College of Law at Cleveland State University. He completed to 20 hour National Highway Traffic Safety Administration Approved Training Courses on Standard Field Sobriety Testing in 1996 and 1997. He is a Past-President of the Cuyahoga County Bar Association. He has lectured at Traffic and DUI Seminars throughout the State of Ohio. In 2005, he obtained a Certificate of Training as an Instructor for the National Highway traffic Safety Administration (NHTSA) DWI Detection and Standardized Field Sobriety Testing Program. Ken also obtained a Certificate of Competency in the Operation, Diagnostic Verification and Calibration for the BAC DataMaster Breath Alcohol Testing Instrument. He has also served as a consultant (expert) regarding Field Sobriety Testing Program. He has also served as a consultant (expert) regarding Field Sobriety Tests in an Aggravated Vehicular Homicide and other OVI cases.

### Joe Hada

Joseph Hada is an Attorney for Quinn Legal Associates. He has dedicated his practice to OVI/DUI, Criminal and Traffic Defense. As a former public defender, Joseph has a wealth of experience in defending OVI/DUI, Criminal and Traffic charges from arraignment through trial and on to appellate argument. He has shared his expertise as a speaker at OVI seminars across Ohio on a variety of topics and is dedicated to remaining on the forefront of OVI defense issues in Ohio. He regularly attends advanced DUI Defense training and seminars regarding Standardized Field Sobriety Testing, Advanced Roadside Impaired Driving Enforcement, Forensic Chromatography, Breath, Blood and Urine Testing, and trial tactics.

### Jon Saia

Jon Saia has over 27 years of experience in defending OVI cases. The focus of his practice is OVI defense. Beyond representing individuals charged with OVI, he also provides consultation and expert testimony on the issue of field sobriety testing and is often consulted by colleagues with regard to breath testing issues. The National Highway Traffic Safety Administration (NHTSA) and the International Association of Chiefs of Police (IACP) have certified Mr. Saia as an Instructor in DUI Detection and Standardized Field Sobriety Testing. In addition, the National Patent Analytical Systems, Inc. (the manufacturer of the BAC Datamaster) has certified Mr. Saia in the operation, diagnostic verification and calibration of the BAC Datamaster Breath Alcohol Testing Instrument, the most commonly used breath testing instrument in Ohio. Recently, Mr. Saia completed training in the operation of the Intoxilyzer 8000 Breath Alcohol Testing Instrument. With blood alcohol testing becoming more prevalent in Ohio, Mr. Saia completed a course in Gas Chromatography and Metrology in order to better defend his clients. Mr. Saia has also completed the NHTSA and IACP sponsored Drug Evaluation and Classification Program in light of Ohio's relatively new Driving Under the Influence of Drugs (DUID) laws. In addition to speaking at seminars, Mr. Saia participates in approximately 40 hours per year of continuing legal education, both locally and nationally, regarding DUI defense.

### Meredith O'Brien

Meredith O'Brien is an Associate Attorney at the Law Offices of Saia & Piatt, Inc. in Cleveland, Ohio. Prior to joining the firm, Ms. O'Brien was in private practice in Northeast Ohio and gained courtroom and trial experience as a Public Defender where she handled hundreds of criminal cases from arraignment through trial. Judge Weiler was elected to the Garfield Heights Municipal Court in November, 1999 for the term beginning January 1, 2000, re-elected November, 2005 for the term beginning January 1, 2006, and November, 2011 for the term beginning January 1, 2012. She received her JD from Cleveland Marshall College of Law. Judge Weiler is a frequent lecturer on OVI Law.

### Candace Kim Knox

Candace Kim Knox is a lifelong Summit County resident and graduate of University of Akron Law School. She graduated from Kent State as a Biology/Pre-Med major. Attorney Knox began her career at the Summit County Prosecutor's Office before going into private practice. She is a member of DUIDLA, a founding member of the American Association of Premier DUI Attorneys, and the Akron Bar Association.
