# **Judge Roger Binette**

Judge Roger E. Binette is in his third term as a Judge in the General Division of the Erie County Common Pleas Court. Judge Binette hears <u>Civil</u>, <u>Criminal</u>, <u>Domestic Relations</u> and <u>Probate cases</u>. His first jury trial was a "cold case", where a defendant was convicted of a rape that had occurred ten (10) years earlier. The defendant was convicted with DNA evidence, in spite of the fact that the victim was unable to identify her assailant. During his terms on the bench Judge Binette has presided over 70 trials. The criminal trials include cases for murders, rapes, shootings, criminal gangs and drugs. The civil trials include medical malpractice, personal injury torts, and fraudulent cases. His most recent civil trial resulted in a verdict of over one million dollars against an insurance company for Bad Faith.

Judge Binette began his journey through the criminal justice field over 32 years ago. At the age of 20, he became a Child Care Worker (Corrections Officer) at the Erie County Detention Home. At the age of 21, he was then promoted to Assistant Director of the Detention Home. At the age of 23, he became a Juvenile Probation Officer.

From 1991 - 2004, Judge Binette was an assistant Prosecutor with Erie Co., assigned to the Erie County Drug Task Force. During his tenure at the Drug Task Force, he garnered many accomplishments. He was actively involved in "boarding up" of local bars, apartment buildings, and crack houses where drugs were sold. He is the creator and author of *Ohio's Forfeiture Law Manual*, a manual that was widely utilized by prosecutors within the State of Ohio. Judge Binette has also been a guest lecturer at various seminars

around the State of Ohio. These include lecturing at the Ohio Attorney General Conference on Law Enforcement, and the Ohio Prosecuting Attorneys Association.
